SECRETARY-GENERAL DAG HAMMARSKJOLD TO VISIT LONDON

The Secretary-General of the United Nations has had the opportunity following the recent session of the General Assembly to confer with a number of member governments and had hoped to visit London on his way back from the Middle East after Christmas.

This, however, proved impracticable at that time and Mr. Hammarskjold has suggested that he should pay this deferred visit next week, when his engagements permit him to leave UN Headquarters for a brief period. The Foreign Secretary welcomed his suggestion and the Secretary-General is therefore flying to London on Wednesday, January 15th, and will be his guest on Thursday evening.

This visit will give an opportunity for a general review and an exchange of views on United Nations affairs.
