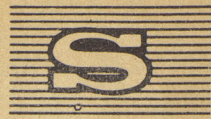

CABLE DATED 9 AUGUST 1961 FROM THE STATE SECRETARY
OF KUWAIT ADDRESSED TO THE PRESIDENT OF THE
SECURITY COUNCIL

I HAVE THE HONOUR TO DRAW YOUR ATTENTION TO THE REPEATED STATEMENTS WHICH HAVE BEEN RECENTLY MADE BY THE IRAQI PREMIER ABDUL KARIM KASSEM, IN WHICH HE THREATENED ANNEXATION OF KUWAIT BY IRAQ. PARTICULARLY I REFER TO KASSEM'S STATEMENTS MADE ON 3 AUGUST 1961 ON THE OCCASION OF LAYING FOUNDATION FOR A CONCRETE FACTORY, WHEN HE SAID, "YES, WE WANT TO LIBERATE KUWAIT AND IF THEY DESIRE THE WORD ANNEXATION WE SHALL ANNEX KUWAIT BY FORCE AND DESPITE THEIR NOSES." LIKEWISE I HAVE THE HONOUR TO DRAW YOUR ATTENTION TO THE REPEATED PROVOCATIVE BROADCASTS AND COMMENTARIES ANNOUNCED PRACTICALLY DAILY FROM IRAQ CONTAINING PROVOCATIVE STATEMENTS ANNOUNCING THE DETERMINATION OF THE IRAQI GOVERNMENT TO ANNEX KUWAIT.

SUCH STATEMENTS CONTINUE TO AGGRAVATE THE SITUATION CREATED BY THE IRAQI PREMIER, AS WAS CLEARLY SHOWN WHEN THE SECURITY COUNCIL DISCUSSED THE COMPLAINT OF KUWAIT AGAINST IRAQ. THIS ATTITUDE BY IRAQ IS IN DIRECT CONTRADICTION TO THE IRAQI DELEGATE'S STATEMENT REPEATED IN THE SECURITY COUNCIL THAT IRAQ SHALL NOT RESORT TO FORCE IN PURSUING HER CLAIM UPON KUWAIT. I SHALL BE MOST GRATEFUL IF YOUR EXCELLENCY WILL TAKE NECESSARY MEASURES TO CIRCULATE THIS CABLE AMONGST SECURITY COUNCIL MEMBERS.

TELEGRAMME ADRESSE AU PRESIDENT DU CONSEIL DE SECURITE,
LE 9 AOUT 1961, PAR LE SECRETAIRE D'ETAT DU KOWEIT

J'ai l'honneur d'attirer votre attention sur les déclarations faites à maintes reprises, ces derniers temps, par M. Abdul Karim Kassem, Premier Ministre de l'Irak, dans lesquelles il menace le Koweït d'annexion par l'Irak. Je me réfère en particulier à la déclaration suivante de M. Kassem, faite le 3 août 1961 à l'occasion de la mise en chantier d'une fabrique de ciment : "Oui, nous voulons libérer le Koweït et, s'ils veulent qualifier cela d'annexion, nous annexerons le Koweït par la force, que cela leur plaise ou non". J'attire de même votre attention sur les multiples émissions radiodiffusées et commentaires de caractère provocateur qui proviennent presque chaque jour de l'Irak et qui contiennent des déclarations provocatrices proclamant la volonté qu'a le Gouvernement irakien d'annexer le Koweït.

Ces déclarations continuent d'aggraver la situation qui a été créée par le Premier Ministre de l'Irak, comme on l'a bien vu lorsque le Conseil de sécurité a examiné la plainte du Koweït contre l'Irak. Cette attitude de l'Irak est en contradiction directe avec la déclaration que le représentant de ce pays a répétée au Conseil de sécurité, à savoir que l'Irak ne recourrait pas à la force pour faire valoir ses revendications sur le Koweït. Je serais très obligé à Votre Excellence de bien vouloir faire distribuer le présent télégramme aux membres du Conseil de sécurité.

YOUR EXCELLENCY TO THE REPEATED PRESS RELEASES
OF THE PRIME MINISTER OF IRAQ BY WHICH HE IS TRYING
TO INCREASE THE TENSION OF THE PRESENT SITUATION STOP
I BEG SPECIFICALLY TO CALL ATTENTION TO THE IRAQI
PRIME MINISTERS PRESS RELEASE OF SEPTEMBER FOUR
IN AN IRAQI PAPER WHERE HE ALLEGES THE EXISTENCE OF
AN OFFICIAL MOVEMENT IN KUWAIT TO TORTURE AND PERSECUTE
IRAQI NATIONAL IN KUWAIT STOP THE PRIME MINISTER IS
THUS DELIBERATELY AROUSING IRAQI PUBLIC OPINION
AGAINST KUWAIT AND I SHOULD THEREFORE BE GRATEFUL
YOUR EXCELLENCY IF YOU WILL ARRANGE FOR THE
DISTINGUISHED MEMBERS OF OXXX OF YOUR COUNCIL TO BE
INFORMED OF THIS MESSAGE
