Your first cable point 5. Contents Santa Cruz telegram go beyond views expressed previously. Consider that what should be done is that Protitch contacts SA delegation in accordance alternative B repeat B as that best corresponding to previous discussion. In doing so he could try out alternative A without emphasis# and ^{have} ~~had~~ alternative C and D as possible lines of retreat.

Consider reply to SA would be that in accordance previous discussion we do not feel that we should press for more than alternative B but will of course explore all possibilities.

Would you transmit following message to Soviet delegation. Since delegation has given me notice of Mr. Zinchenkos nonreturn and resignation I have considered alternative candidates for his succession for the remaining part of his term of office. On the basis of this considerations I would like the Soviet delegation to forward to Mr. Chernyshev former Ambassador of USSR to Stockholm the following offer.

Primo. I offer Mr. Chernyshev an assignment as Assistant Secretary General for completion of Mr. Zinchenkos term, that is to the 1st of February - ? - 1954.

Secundo. Terms of contract would be the normal one, 23.000 dollars gross, 15.000 dollars net with 7.000 dollars representation allowance plus removal costs plus education grants if children of school age.

Tertio. Valuable if Mr. Chernyshev could take up his office about middle of June when I am returning to New York.

Quarto. Announcement of Assignment will be made as soon as an answer if affirmative has been received.
